Even 25 years ago this forest was being plundered by people who were using it for their local landscape supply...likely to sell as high end landscaping in Santa Fe. There was also durable goods dumping where people had road access. And to this day it is the only national forest where people were firing guns at night while camping. Clearly this area needs protection. Thank you for the opportunity to comment on the Scoping Document for the Santa Fe Mountains Landscape Resiliency Project. I appreciate the Forest Service soliciting public comment on this project, but have a number of concerns with the Forest Service's proposal:

1. An EA is inappropriate for a project of this scale and complexity that impacts many threatened and sensitive species, old growth forests, roadless areas and streams and riparian areas. Because this project will have significant impacts to these and other resources, a thorough, site-specific analysis of all environmental impacts in an Environmental Impact Statement is required.
2. The Forest Service must analyze a full range of alternatives to the agency's proposal, including the Santa Fe Conservation Alternative submitted by WildEarth Guardians and others.
3.
