At Fruit of the Earth, with your help, we plant a tree for every purchase you make, and have to date planted 53,000 trees.

Ordinarily we wouldn't bother you, but the U.S. Forest Service suggests in its new proposal "Santa Fe Mountains Landscape Resiliency Project" slated for our local Sangre de Cristo Mountains, we cut down most trees and shrubs across up to 33 square miles and set prescribed fires across up to 67 square miles.

A recent study indicates our best path to stem off climate change is planting trees, and an end to deforestation. The Forest Service is exacerbating the greatest problem of our time, and at the same time destroying the natural beauty of our region. It's not too late for you to comment, comment period ends Wednesday.
